**PURPOSE & INTENT:** To keep detachment members; especially, members who do not regularly attend meetings, informed of past and future detachment actions and activities. To present information concisely.

**HIGHLIGHTS OF THE DETACHMENT MARCH MEETING:**

**ONE-TIME MEETING LOCATION CHANGE:** Because the May meeting's primary purpose is the installation of new officers, a one-time change for the meeting's location was proposed and approved by the members present.

The May meeting will be an official detachment social event that includes the installation ceremony for newly elected detachment officers; accordingly, members are encouraged to bring their spouse and/or other guests. DECEASED MARINE: While not a detachment member, we regretfully report that an interment service for LCpl Randall Wright, U. S. Marine Corps (Ret) will take place at the Idaho Veterans Cemetery on May 11 at or about 2:45 PM. LCpl Wright was a triple amputee from the war in Afghanistan. His specific cause of death has, to my knowledge, not been publicly reported, but it is reasonable to assume that the cause is somehow related to his wounds. For the sake of his family we encourage all members to attend this interment if you are physically able to do so.

His retirement has been delayed, apparently, until a replacement can be recruited. His will be a very tough act to follow.

GOOD OF THE LEAGUE: Your newsletter editor made a semi-lengthy presentation during the Good of the League portion of the April meeting that I will summarize for you here: I argued that in my view the detachment is slipping away from its

formerly vigorous state and that together we should resolve to undertake the necessary work to rejuvenate our organization. I also argued that each of us should study the stated purposes of the Marine Corps League to the point of near memorization because the League's purposes should guide the goals and objectives of our detachment. I further argued that we need to establish a new-member orientation and mentoring program so that our new members may come to understand the detachment and the League quickly, and that we also need a continuing training program to help members become both interested in and ready for detachment leadership positions. Finally, I argued that we need to develop a Detachment Vision Statement that is based on our understanding of the Purpose of the Marine Corps League, and suggested ways that we might go about accomplishing each of those tasks.

If you want to read my complete presentation, then let me know and I will provide you a copy.

For your immediate reference the Purposes of the Marine Corps League are:

- To preserve the traditions, promote the interest, and perpetuate the history of the United States Marine Corps and, by fitting acts, to observe the anniversaries of historical occasions that are of particular interest to Marines.
- To band together those who are now serving the United States Marine Corps and those who have been honorably discharged from that service together in fellowship, that they may effectively promote the ideals of American freedom and democracy.
- To fit its members for the duties of citizenship and to encourage them to serve as ably as citizens as they served their nation under arms.
- To hold sacred the memory and history of men who have given their lives to the nation.
- To foster love for the principles that they have supported by blood and valor since the founding of the Republic.
- To aid voluntarily and to render assistance to all Marines, uniformed and civilian, as well as to their widows and orphans.

INFORMATION: The newsletter may include comments from the Detachment Commandant, other detachment officers, and detachment committee and special project chairmen/women. The newsletter may also include comments from detachment members who have "good of the league" information they believe their fellow Marines and Corpsmen should either know, consider, or be aware of. Such letters may not exceed 200 words and may be submitted to the newsletter editor at [g.randeljr@att.net](mailto:g.randeljr@att.net) for consideration by the detachment's board of trustees for inclusion in a future newsletter.
